

Administration of Justice Occupations Labor Market Information Report Chabot College

Prepared by the San Francisco Bay Center of Excellence for Labor Market Research
January 2021

Recommendation

Based on all available data, there appears to be an "undersupply" of Administration of Justice workers compared to the demand for this cluster of occupations in the Bay region and in the East Bay sub-region (Alameda and Contra Costa counties). There is a projected annual gap of about 294 students in the Bay region and 118 students in the East Bay Sub-Region.

Introduction

This report provides student outcomes data on employment and earnings for TOP 2105.00 - Administration of Justice programs in the state and region. It is recommended that these data be reviewed to better understand how outcomes for students taking courses on this TOP code compare to potentially similar programs at colleges in the state and region, as well as to outcomes across all CTE programs at Chabot College and in the region.

This report profiles Administration of Justice Occupations in the 12 county Bay region and in the East Bay sub-region for a proposed new program at Chabot College.

It is important to note that Chabot College submitted five occupations in the LMI request form, that they indicate align with the Administration of Justice program they are proposing. However, two of these occupations (Lawyers and Judicial Law Clerks) require professional degrees (after a four-year degree). Because community colleges cannot award professional degrees, the occupational data for these two occupations is included for reference, regarding future "pathway occupations" that students could pursue after completing a four-year degree, but is not included in the "gap analysis" comparing occupational demand and college supply.

• Lawyers (23-1011): Represent clients in criminal and civil litigation and other legal proceedings, draw up legal documents, or manage or advise clients on legal transactions. May specialize in a single area or may practice broadly in many areas of law.

Entry-Level Educational Requirement: Doctoral or professional degree

Training Requirement: None

Percentage of Community College Award Holders or Some Postsecondary Coursework: 1.2 %

• **Judicial Law Clerks (23-1012):** Assist judges in court or by conducting research or preparing legal documents. Excludes "Lawyers" (23-1011) and "Paralegals and Legal Assistants" (23-2011).

Entry-Level Educational Requirement: Doctoral or professional degree

Training Requirement: None

Percentage of Community College Award Holders or Some Postsecondary Coursework: 11.0 %

Correctional Officers and Jailers (33-3012): Guard inmates in penal or rehabilitative institutions in accordance
with established regulations and procedures. May guard prisoners in transit between jail, courtroom, prison, or
other point. Includes deputy sheriffs and police who spend the majority of their time guarding prisoners in
correctional institutions.

Entry-Level Educational Requirement: High school diploma or equivalent

Training Requirement: Moderate-term on-the-job training

Percentage of Community College Award Holders or Some Postsecondary Coursework: 48.7 %

 Police and Sheriffs Patrol Officers (33-3051): Maintain order and protect life and property by enforcing local, tribal, State, or Federal laws and ordinances. Perform a combination of the following duties: patrol a specific area; direct traffic; issue traffic summonses; investigate accidents; apprehend and arrest suspects, or serve legal processes of courts.

Entry-Level Educational Requirement: High school diploma or equivalent

Training Requirement: Moderate-term on-the-job training

Percentage of Community College Award Holders or Some Postsecondary Coursework: $48.6\ \%$

 Public Safety Telecommunicators (43-5031): Operate radio, telephone, or computer equipment at emergency response centers. Receive reports from the public of crimes, disturbances, fires, and medical or police emergencies. Relay information to law enforcement and emergency response personnel. May maintain contact with caller until responders arrive.

Entry-Level Educational Requirement: High school diploma or equivalent

Training Requirement: Moderate-term on-the-job training

Educational Supply

There are 23 community colleges in the Bay Region issuing 1,817 awards on average annually (last 3 years ending 2018-19) on TOP 2105.00 - Administration of Justice. In the East Bay Sub-Region, there are seven (7) community colleges that issued 369 awards on average annually (last 3 years) on this TOP code.

There are a three (3) other CTE educational institutions in the Bay Region issuing 14 awards on average annually (last 3 years ending 2016-17) on TOP 2105.00 - Administration of Justice. There are two (2) other CTE educational institutions in the East Bay Sub-Region issuing 8 awards on average annually (last 3 years) on this TOP code.

Gap Analysis

Based on the data included in this report, there is a labor market gap in the Bay region with 2,125 annual openings (requiring less than a four-year degree) for the Administration of Justice occupational cluster and 1,831 annual (3-year average) awards for an annual undersupply of 294 students. In the East Bay Sub-Region, there is also a gap with 495 annual openings (requiring less than a four-year degree) and 377 annual (3-year average) awards for an annual undersupply of 118 students.

Labor demand data is sourced from Economic Modeling Specialists International (EMSI) occupation data and Burning Glass job postings data. Educational supply and student outcomes data is retrieved from multiple sources, including CTE Launchboard and CCCCO Data Mart.
