Recommendation

Based on all available data, there appears to be an "undersupply" of Legal Studies workers compared to the demand for this cluster of occupations in the Bay region and in the East Bay sub-region (Alameda, Contra Costa counties). There is a projected annual gap of about 143 students in the Bay region and 55 students in the East Bay Sub-Region.

Introduction

This report provides student outcomes data on employment and earnings for TOP 2105.00 - Administration of Justice programs in the state and region. It is recommended that these data be reviewed to better understand how outcomes for students taking courses on this TOP code compare to potentially similar programs at colleges in the state and region, as well as to outcomes across all CTE programs at Chabot College and in the region.

This report profiles Legal Studies Occupations in the 12 county Bay region and in the East Bay sub-region for a proposed new program at Chabot College.

It is important to note that Chabot College submitted five occupations in the LMI request form, that they indicate align with the Legal Studies program they are proposing. However, two of these occupations (Lawyers and Judicial Law Clerks) require professional degrees (after a four-year degree). Because community colleges cannot award professional degrees, the occupational data for these two occupations is included as a reference as a future "pathway occupation" that students could pursue after completing a four-year degree, but is not included in the "gap analysis" comparing occupational demand and college supply.

• Lawyers (23-1011): Represent clients in criminal and civil litigation and other legal proceedings, draw up legal documents, or manage or advise clients on legal transactions. May specialize in a single area or may practice broadly in many areas of law.

Training Requirement: None

Percentage of Community College Award Holders or Some Postsecondary Coursework: 1%

• **Judicial Law Clerks (23-1012):** Assist judges in court or by conducting research or preparing legal documents. Excludes "Lawyers" (23-1011) and "Paralegals and Legal Assistants" (23-2011).

Entry-Level Educational Requirement: Doctoral or professional degree

Training Requirement: None

Percentage of Community College Award Holders or Some Postsecondary Coursework: 11%

 Paralegals and Legal Assistants (23-2011): Assist lawyers by investigating facts, preparing legal documents, or researching legal precedent. Conduct research to support a legal proceeding, to formulate a defense, or to initiate legal action. Excludes "Legal Secretaries" (43-6012).

Legal Support Workers, All Other (23-2099): All legal support workers not listed separately.

 Legal Secretaries and Administrative Assistants (43-6012): Perform secretarial duties using legal terminology, procedures, and documents. Prepare legal papers and correspondence, such as summonses, complaints, motions, and subpoenas. May also assist with legal research.

Training Requirement: Moderate-term on-the-job training

Educational Supply

There are twenty-three (23) community colleges in the Bay Region issuing 1,817 awards on average annually (last 3 years ending 2018-19) on TOP 2105.00 - Administration of Justice. In the East Bay Sub-Region, there are seven (7) community colleges that issued 369 awards on average annually (last 3 years) on this TOP code.

There are a three (3) other CTE educational institutions in the Bay Region issuing 14 awards on average annually (last 3 years ending 2016-17) on TOP 2105.00 - Administration of Justice. There is two (2) other CTE educational institution in the East Bay Sub-Region issuing 8 awards on average annually (last 3 years) on this TOP code.

Gap Analysis

Based on the data included in this report, there is a labor market gap in the Bay region with 1,974 annual openings for the Legal Studies occupational cluster (requiring less than a four-year degree) and 1,831 annual (3-year average) awards for an annual undersupply of 143 students. In the East Bay Sub-Region, there is also a gap with 432 annual openings for the Legal Studies occupational cluster (requiring less than a four-year degree) and 377 annual (3-year average) awards for an annual undersupply of 55 students.

Labor demand data is sourced from Economic Modeling Specialists International (EMSI) occupation data and Burning Glass job postings data.
