The Orange County Center of Excellence for Labor Market Research (COE) prepared this report to provide Los Angeles/Orange County regional labor market supply and demand data related to four middle-skill occupations: barbers (39-5011), hairdressers, hairstylists, and cosmetologists (39-5012), manicurists and pedicurists (39-5092), and skincare specialists (39-5094). Middle-skill occupations typically require some postsecondary education, but less than a bachelor's degree. This report is intended to help determine whether there is demand in the local labor market that is not being met by the supply from community college programs that align with the relevant occupations.

Based on the available data, there appears to be a supply gap for these cosmetology occupations in the region. While the Bureau of Labor Statistics (BLS) lists these occupations as typically requiring a postsecondary non-degree award, entry-level wages are lower than the living wage in both Los Angeles and Orange counties. Therefore, due to some of the criteria being met, the COE endorses this proposed program. Detailed reasons include:

Demand:

Supply Gap Criteria – Over the next five years, there is projected to be 8,013 jobs
 available annually in the region due to new job growth and replacements, which is

more than the 5,846 awards conferred annually by educational institutions in the region.

- Over the past 12 months, there were 2,964 online job postings related to these four cosmetology occupations.
- However, there were only 21 online job postings for cosmetology, barber, and/or esthetician instructors during this same time period.
- Living Wage Criteria Within Orange County, all of the annual job openings for these four cosmetology occupations have entry-level wages below the county's living wage (\$17.36/hour) likely, at least in part, due to the large number of self-employed people in these occupations.²
 - The majority of barbers (99%) and hairdressers, hairstylists and cosmetologists (66%) in the LA/OC region are self-employed and list self-employment as their primary source of income. Note: See the Wage narrative section for further explanation regarding low wages for these occupations.
- Educational Criteria The Bureau of Labor Statistics (BLS) lists a postsecondary nondegree award as the typical entry-level education for these cosmetology occupations.
 - The national-level educational attainment data indicates between 35.6% and 52.0% of barbers, hairdressers, hairstylists, and cosmetologists, and skincare specialists in the field have completed some college or an associate degree.
 - However, only 24.2% of manicurists and pedicurists in the field have completed some college or an associate degree.

Supply:

- There are 11 community colleges in the LA/OC region that issue awards related to cosmetology and barbering, conferring an average of 862 awards annually between 2016 and 2019.
- Between 2014 and 2017, there was an average of 4,984 awards conferred annually in related training programs by non-community college institutions throughout the region.

Occupational Demand

Exhibit 1 shows the five-year occupational demand projections for these cosmetology occupations. In Los Angeles/Orange County, the number of jobs related to these occupations is projected to increase by 10% through 2024. There will be more than 8,000 job openings per year through 2024 due to job growth and replacements.

This report includes employment projection data by Emsi which uses EDD information. Emsi's projections are modeled on recorded (historical) employment figures and incorporate several underlying assumptions, including the assumption that the economy, during the projection period, will be at approximately full employment. To the extent that a recession or labor shock, such as the economic effects of COVID-19, can cause long-term structural change, it may impact the projections.

At this time, it is not possible to quantify the impact of COVID-19 on projections of industry and occupational employment. Therefore, the projections included in this report do not take the impacts of COVID-19 into account.

Wages

The labor market endorsement in this report considers the entry-level hourly wages for these cosmetology occupations in Orange County as they relate to the county's living wage. Los Angeles County wages are included below in order to provide a complete analysis of the LA/OC region. Detailed wage information, by county, is included in Appendix A.

The majority of barbers (99%) and hairdressers, hairstylists and cosmetologists (66%) in the LA/OC region are self-employed and list self-employment as their primary source of income.⁴ Self-employed workers have different earnings dynamics than wage and salaried workers, making direct comparisons difficult. Examples include deciphering what is a return to labor versus a return to capital, as well as showing possible negative earnings if expenses or investments exceed gross receipts.⁵ For these reasons, wage data appears low throughout the region due to the high percentage of self-employed workers within these two occupations.

Orange County— All of the annual openings for cosmetology occupations have entry-level wages below the living wage for one adult (\$17.36 in Orange County).⁶ Typical entry-level hourly wages are in a range between \$6.88 and \$12.00, which is lower than both the living wage as well as California's current minimum wage (\$12.00/hour for employers with 25 employers or less; \$13.00/hour for employers with 26 or more employees).⁷ Experienced hairdressers, hairstylists and cosmetologists and skincare specialists can expect to earn \$20.28 and \$20.24, respectively, in hourly wages, which exceeds the living wage estimate. However, experienced barbers and manicurists and pedicurists can expect to earn hourly wages that are lower than the living wage estimate (\$17.20 and \$15.10, respectively). Orange County's average wages are below the average statewide wage of \$17.46 for these occupations.

Los Angeles County— All of the annual openings for cosmetology occupations have entry-level wages below the living wage for one adult (\$15.04 in Los Angeles County). Typical entry-level hourly wages are in a range between \$6.81 and \$12.06, which is lower than both the living wage as well as California's current minimum wage. Experienced barbers, hairdressers, hairstylists and cosmetologists and skincare specialists can expect to earn between \$17.07 and \$20.71 in hourly wages, which exceeds the living wage estimate. However, experienced manicurists and pedicurists can expect to earn hourly wages that are lower than the living wage estimate (\$15.12). Los Angeles County's average wages are below the average statewide wage of \$17.46 for these occupations.

Job Postings

There were 2,964 online job postings related to these four cosmetology occupations listed in the past 12 months. The highest number of job postings were for hair stylists, estheticians, nail technicians, barbers, and wax specialists. The top skills were: hair styling, client base retention, scheduling, sales, and skin care. The top three employers, by number of job postings, in the region were: Great Clips, Regis Corporation, and Sport Clips.

However, there were only 21 online job postings related to cosmetology, barbering, and/or esthetician instructors listed in the past 12 months. The highest number of job postings were for cosmetology instructors (8 postings), cosmetology instructor pool (6), and barbering instructors (2). The top skills were: teaching, customer service, cleaning, educational programs, and lesson planning. The top employers, by number of job postings, in the region were: Aveda Institute, Paul Mitchell Schools, Los Angeles Community College District, and Jama's Beauty and Barber College.

It is important to note that the job postings data included in this section reflects online job postings listed in the past 12 months and does not yet demonstrate the impact of COVID-19. While employers have generally posted fewer online job postings since the beginning of the pandemic, the long-term effects are currently unknown.

Educational Attainment

The Bureau of Labor Statistics (BLS) lists a postsecondary non-degree award as the typical entry-level education for all four cosmetology occupations in this report. While the national-level educational attainment data indicates between 35.6% and 52.0% of barbers, hairdressers, hairstylists, and cosmetologists, and skincare specialists in the field have completed some college or an associate degree, only 24.2% of manicurists and pedicurists in the field have completed the same level of education. Only 7% of the 2,964 cosmetologist job postings listed a minimum education requirement, and this is most likely due to the fact that the beauty industry is regulated in California by the California Board of Barbering and Cosmetology and holding a license is more important for employers than a specific level of education⁸.

Educational Supply

Community College Supply—Exhibit 2 shows the three-year average number of awards conferred by community colleges in the related TOP code: Cosmetology and Barbering (3007.00). The colleges with the most completions in the region are: Saddleback, Citrus, Fullerton

and Golden West. Over the past 12 months, there were two other related program recommendation requests from regional community colleges.

Non-Community College Supply—For a comprehensive regional supply analysis, it is also important to consider the supply from other institutions in the region that provide training programs for the cosmetology occupations in this report. Exhibit 3 shows the annual and three-year average number of awards conferred by these institutions in the related Classification of Instructional Programs (CIP) Codes: Cosmetology/Cosmetologist, General (12.0401), Barbering/Barber (12.04002), Make-Up Artist/Specialist (12.0406), Aesthetician/Esthetician and Skin Care Specialist (12.0409), Nail Technician/Specialist and Manicurist (12.0410), Cosmetology, Barber/Styling, and Nail Instructor (12.0413), and Cosmetology and Related Personal Grooming Arts, Other (12.0499). Due to different data collection periods, the most recent three-year period of available data is from 2014 to 2017. Between 2014 and 2017, four-year colleges in the region conferred an average of 4,984 awards annually in related training programs.
