

# Labor Market Assessment: 2104.40/Alcohol and Controlled Substances Addiction Counseling (Associate of Science; Certificate)

The Los Angeles Center of Excellence for Labor Market Research (LA COE) prepared this report to provide regional labor market supply and demand data related to two middle-skill occupations: social and human service assistants (21-1093), and community health workers (21-1094); and one above middle-skill occupation: substance abuse and behavioral disorder counselors (21-1011). Middle-skill occupations typically require some postsecondary education, but less than a bachelor's degree, while above middle-skill occupations require a bachelor's degree or more education. This report is intended to help determine whether there is demand in the local labor market that is not being met by the supply from community college programs that align with the relevant occupations.

Based on the available data, there appears to be a supply gap for these middle-skill addiction counseling occupations in the region. While the majority of annual openings have entry-level wages that are lower than the self-sufficiency standard wage in both Los Angeles and Orange counties, the occupation with the most annual openings (social and human service assistants) has at least one-third of workers in in the field who have completed some college or an associate degree. Therefore, due to some of the criteria being met, the LA COE endorses this proposed program. Detailed reasons include:

#### **Demand:**

Supply Gap Criteria – Over the next five years, there is projected to be 3,288 jobs
available annually in the region due to new job growth and replacements, which is
more than the 485 awards conferred annually by educational institutions in the
region.

- However, social and human service assistants (21-1093) and community health workers (21-1094) work in many different community and social service subindustries, including addiction counseling. Therefore, the number of job openings is likely overstated for middle-skill addiction counseling occupations.
- Over the past 12 months, there were 2,210 online job postings related to addiction counseling occupations. The highest number of job postings were for substance abuse counselors, care coordinators, social services assistants, outreach specialists, and case management coordinators.
- Living Wage Criteria Within Los Angeles County, the majority (94%) of annual job openings for these addiction counseling occupations have entry-level wages below the self-sufficiency standard hourly wage (\$18.10/hour).<sup>2</sup>
- Educational Criteria —Within the greater LA/OC region, 62% of the annual job openings for occupations related to addiction counseling typically require a high school diploma or equivalent.
  - While the national-level educational attainment data indicates between 13% and 34% of workers in the field have completed some college or an associate degree, the occupation with the majority of the annual openings (social and human service assistants) has at least one-third of workers in in the field who have completed some college or an associate degree.

## Supply:

- There are 11 community colleges in the greater LA/OC region that issue awards related to addiction counseling, conferring an average of 323 awards annually between 2017 and 2020.
- Between 2016 and 2019, there was an average of 92 awards conferred annually in related training programs by non-community college institutions throughout the greater LA/OC region.

#### **Occupational Demand**

Exhibit 1 shows the five-year occupational demand projections for the middle-skill addiction counseling occupations in this report. In Los Angeles/Orange County, the number of jobs related to these occupations is projected to increase by 17% through 2025. There will be nearly 3,300 job openings per year through 2025 due to job growth and replacements.

Social and human service assistants (21-1093) and community health workers (21-1094) work in many different community and social service sub-industries in addition to the field of addiction counseling. Therefore, demand for these occupations within the field of addiction counseling is likely overstated.

This report includes employment projection data by Emsi which uses EDD information. Emsi's projections are modeled on recorded (historical) employment figures and incorporate several underlying assumptions, including the assumption that the economy, during the projection period, will

be at approximately full employment. To the extent that a recession or labor shock, such as the economic effects of COVID-19, can cause long-term structural change, it may impact the projections. At this time, it is not possible to quantify the full impact of COVID-19 on projections of industry and occupational employment. Therefore, the projections included in this report do not take the full impacts of COVID-19 into account.

Exhibit 2 shows the five-year occupational demand projections for the above middle-skill addiction counseling occupation in this report. In Los Angeles/Orange County, the number of jobs related to this occupation is projected to increase by 18% through 2025. There will be nearly 2,000 job openings per year through 2025 due to job growth and replacements. It is also important to note that the labor market research tool Emsi Analyst, which generates the data in this brief, uses a single aggregate code that combines substance abuse and behavioral disorder counselors (21-1011) and mental health counselors (21-1014). Since these two occupations are combined within the dataset, the demand data for substance abuse and behavioral disorder counselors is overstated.

## Wages

The labor market endorsement in this report considers the entry-level hourly wages for all of the addiction counseling occupations in this report (middle-skill and above middle-skill) in Los Angeles County as they relate to the county's self-sufficiency standard wage. Orange County wages are included below in order to provide a complete analysis of the greater LA/OC region. Detailed wage information, by county, is included in Appendix A.

**Los Angeles County—**The majority (94%) of annual openings for these addiction counseling occupations have entry-level wages **below** the self-sufficiency standard wage for one adult (\$18.10 in Los Angeles County). Typical entry-level hourly wages are in a range between \$15.16 and \$18.78. Only one occupation in this report has entry-level wages above the county's self-

sufficiency standard: community health workers (\$18.78). Experienced workers can expect to earn wages between \$24.78 and \$31.90, which are higher than the self-sufficiency standard.

**Orange County**—All of the occupations in this report have entry-level wages <u>below</u> the self-sufficiency standard wage for one adult (\$20.63 in Orange County). Typical entry-level hourly wages are in a range between \$14.33 and \$17.87. Experienced workers can expect to earn wages between \$23.44 and \$29.79, which are higher than the self-sufficiency standard.

#### **Job Postings**

There were 2,210 online job postings related to middle-skill addiction counseling occupations listed in the past 12 months. Exhibit 3 displays the number of job postings by occupation. The majority of job postings (57%) were for social and human service assistants, followed by substance abuse and behavioral disorder counselors (28%) and community health workers (15%). The highest number of job postings were for substance abuse counselors, care coordinators, social services assistants, outreach specialists, and case management coordinators. The top skills were case management, knowledge of mental health, customer service, treatment planning, knowledge of social services and addiction treatment. The top three employers, by number of job postings, in the region were: Anthem Blue Cross, Behavioral Health Services California, and Mental Health America of Los Angeles.

It is important to note that the job postings data included in this section reflects online job postings listed in the past 12 months and does not yet demonstrate the full impact of COVID-19. While employers have generally posted fewer online job postings since the beginning of the pandemic, the long-term effects are currently unknown.

#### **Educational Attainment**

The Bureau of Labor Statistics (BLS) lists the following typical entry-level education levels for the occupations in this report:

- Bachelor's degree: Substance abuse, behavioral disorder, and mental health counselors (21-1018)
- High school diploma or equivalent: Social and human service assistants (21-1093);
   community health workers (21-1094)

In the greater LA/OC region, the majority of annual job openings (62%) typically require a high school diploma or equivalent. While the national-level educational attainment data indicates between 13% and 34% of workers in the field have completed some college or an associate degree, the occupation with the majority of the annual openings (social and human service

assistants) has at least one-third of workers in in the field who have completed some college or an associate degree. Of the 65% of middle-skill addiction counseling job postings listing a minimum education requirement in the greater Los Angeles/Orange County region, 86% (1,231) requested high school or vocational training, and 14% (206) requested an associate degree.

## **Educational Supply**

**Community College Supply**—Exhibit 4 shows the three-year average number of awards conferred by community colleges in the related TOP code: Alcohol and Controlled Substances (2104.40). The colleges with the most completions in the region are: Mt. San Antonio, Long Beach, and East LA.

**Non-Community College Supply—**For a comprehensive regional supply analysis, it is also important to consider the supply from other institutions in the region that provide training programs for addiction counseling. Exhibit 5 shows the annual and three-year average number of awards conferred by these institutions in programs crosswalked to the community college programs listed in Exhibit 4. Due to different data collection periods, the most recent three-year period of available data is from 2016 to 2019. Between 2016 and 2019, four-year colleges in the region conferred an average of 92 awards annually in related training programs.

**Certifications**—California law requires that volunteers, interns, or employees of alcohol and drug treatment facilities are registered with a state certifying body. Once registered, workers have five years to become fully certified, which includes education, testing and training.<sup>4</sup> The California Department of Health Care Services currently recognizes three organizations that register and certify alcohol and other drug counselors in California.<sup>5</sup> Exhibit 6 displays the certification organizations, and the minimum requirements for education, testing and training.

It is worth noting that due to the nature of these registration regulations, individuals do not have to complete their Alcohol and Drug Studies education at a community college, nor complete an associate degree to become certified.
