


Alcohol and Other Drug Occupations

Labor Market Analysis: San Diego County

March 2023

Summary



This brief provides labor market information about Alcohol and Other Drug Occupations to assist the San Diego and Imperial Counties Community Colleges with program development and strategic planning. Alcohol and Other Drug Occupations include "Community and Social Service Specialists, All Other" and "Substance Abuse, Behavioral Disorder, and Mental Health Counselors." According to available labor market information, Alcohol and Other Drug Occupations in San Diego County have a labor market demand of 580 annual job openings (while average demand for a single occupation in San Diego County is 289 annual job openings), and three institutions supply 75 awards for these occupations, suggesting that there is a supply gap in the labor market. On average, entry-level and median wages are above the living wage. This brief recommends proceeding with a new program and supports a program modification because 1) there is a supply gap in San Diego County; 2) entry-level earnings for this occupation are above the living wage; and 3) there is a high number of annual job openings; however, 4) colleges should note that employers typically require a bachelor's degree as the minimum educational requirement for these occupations.

Introduction

This report provides labor market information in San Diego County for the following occupational codes in the Standard Occupational Classification (SOC)¹ system:

- Community and Social Service Specialists, All Other (SOC 21-1099): All community and social service specialists not listed separately.
- Substance Abuse, Behavioral Disorder, and Mental Health Counselors (SOC 21-1018): Counsel
 and advise individuals with alcohol, tobacco, drug, or other problems, such as gambling and
 eating disorders. May counsel individuals, families, or groups or engage in prevention programs.

For the purpose of this report, these occupations are referred to as Alcohol and Other Drug Occupations.

Projected Occupational Demand

Between 2022 and 2027, Alcohol and Other Drug Occupations are projected to increase by 736 net jobs or 18 percent (Exhibit 1a). Employers in San Diego County will need to hire 580 workers annually to fill new jobs and backfill jobs due to attrition caused by turnover and retirement, for example.




Exhibit 1a: Number of Jobs for Alcohol and Other Drug Occupations (2012-2027)2

Exhibit 1b disaggregates the projected number of jobs change by occupation. "Substance Abuse, Behavioral Disorder, and Mental Health Counselors" are projected to have the most labor market demand between 2022 and 2027, with 451 annual job openings.

Earnings

Exhibit 2a disaggregates hourly earnings by occupation. The entry-level hourly earnings for *Alcohol and Other Drug Occupations* range from \$18.36 to \$18.71.



On average, the entry-level hourly earnings for *Alcohol and Other Drug Occupations* are \$18.54; this is slightly more than the living wage for a single adult in San Diego County, which is \$18.43 per hour (Exhibit 2b).⁵





Educational Supply

Educational supply for an occupation can be estimated by analyzing the number of awards in related Taxonomy of Programs (TOP) or Classification of Instructional Programs (CIP) codes.⁸ There is one TOP code and one CIP code related to *Alcohol and Other Drug Occupations* (Exhibit 3).

According to TOP data, two community colleges supply the region with awards for these occupations: Palomar College and San Diego City College. According to CIP data, one non-community-college institution supplies the region with awards, National University (Exhibit 4).

Demand vs. Supply

Comparing labor demand (annual openings) with labor supply¹⁰ suggests that there is a supply gap for these occupations in San Diego County, with 580 annual openings and 75 awards. Comparatively, there are 7,610 annual openings in California and 1,072 awards, suggesting that there is also a supply gap across the state¹¹ (Exhibit 5).

Please note: This is a basic analysis of supply and demand of labor. The data does not include workers currently in the labor force who could fill these positions or workers who are not captured by publicly available data. This data should be used to discuss the potential gaps or oversupply of workers; however, it should not be the only basis for determining whether or not a program should be developed.



Student Outcomes and Regional Comparisons

According to the California Community Colleges LaunchBoard, 35 percent of students in the San Diego-Imperial region earned a living wage after completing a program related to *Alcohol and Other Drug* Occupations, compared 39 to 54 percent statewide and 52 percent of students in Career Education programs in general across the state (Exhibit 6a).¹³

Exhibit 6a: Percentage of Students Who Earned a Living Wage by Program, PY2019-2014





According to the California Community Colleges LaunchBoard, 73 percent of students in the San Diego-Imperial region obtained a job closely related to their field of study after completing a program related to Alcohol and Other Drug Occupations, compared to 73 to 81 percent statewide and 73 percent of students in Career Education programs in general across the state (Exhibit 6b).¹⁵

Exhibit 6b: Percentage of Students in a Job Closely Related to Field of Study by Program, PY2018-1916





Online Job Postings

This report analyzes not only historical and projected (traditional LMI) data, but also recent data from online job postings (real-time LMI). Online job postings may provide additional insight about recent changes in the labor market that are not captured by historical data. Between 2019 and 2022, there was an average of 1,695 online job postings per year for *Alcohol and Other Drug Occupations* in San Diego County (Exhibit 7). Please note that online job postings do **not** equal labor market demand; demand is represented by annual job openings (see Exhibit 1b). While this brief includes online jobs postings data to help with curriculum development, the community colleges should note that this type of data is impacted by several variables: employers may post a position multiple times to increase the pool of applicants; a job posting can remain posted after a business decides not to fill a position; or an employer may use one posting to fill multiple positions, for example.

Top Employers

Between January 1, 2020 and December 31, 2022, the top five employers in San Diego County for Alcohol and Other Drug Occupations were Community Research Foundation, Mental Health Systems, Union Of Pan Asian Communities, Telecare Corporation, and Acadia Healthcare based on online job postings (Exhibit 8).

Education, Skills, and Certifications

Alcohol and Other Drug Occupations have a national educational attainment of a bachelor's degree (Exhibit 9a).



Based on online job postings between January 1, 2020 and December 31, 2022 in San Diego County, employers posted a master's degree or higher as the most requested educational requirement for *Alcohol and Other Drug Occupations* (Exhibit 9b).²⁰
