### Program Recommendation

This report was compiled by the South Central Coast<sup>1</sup> Center of Excellence to provide regional labor market data for the program recommendation – Finance. This report can help determine whether there is demand in the local labor market that is not being met by the supply from programs of study that align with these occupations:

- Financial and Investment Analysts
- Bookkeeping, Accounting, and Auditing Clerks

### Key Findings

- In 2022, there were 9,175 jobs for the two occupations of interest in the South Central Coast Region.
- This number is expected to increase by 2% through 2027.
- Projections show approximately 1,338 annual openings in the region. There were 592 awards conferred in relevant programs, indicating an undersupply.
- According to the Bureau of Labor Statistics, Bookkeeping, Accounting, and Auditing Clerks typically require some college, no degree. Financial and Investment Analysts typically require a bachelor's degree.

## Occupation Codes and Descriptions

There are two occupations in the standard occupational classification (SOC) system that were identified for this analysis. The occupation titles and descriptions, as well as reported job titles, are included in Exhibit 1.

## Current and Future Employment

In the South Central Coast region, the number of jobs for Finance-related occupations is expected to increase 2% through 2027. Approximately 1,338 annual openings are expected through 2027.

## Earnings

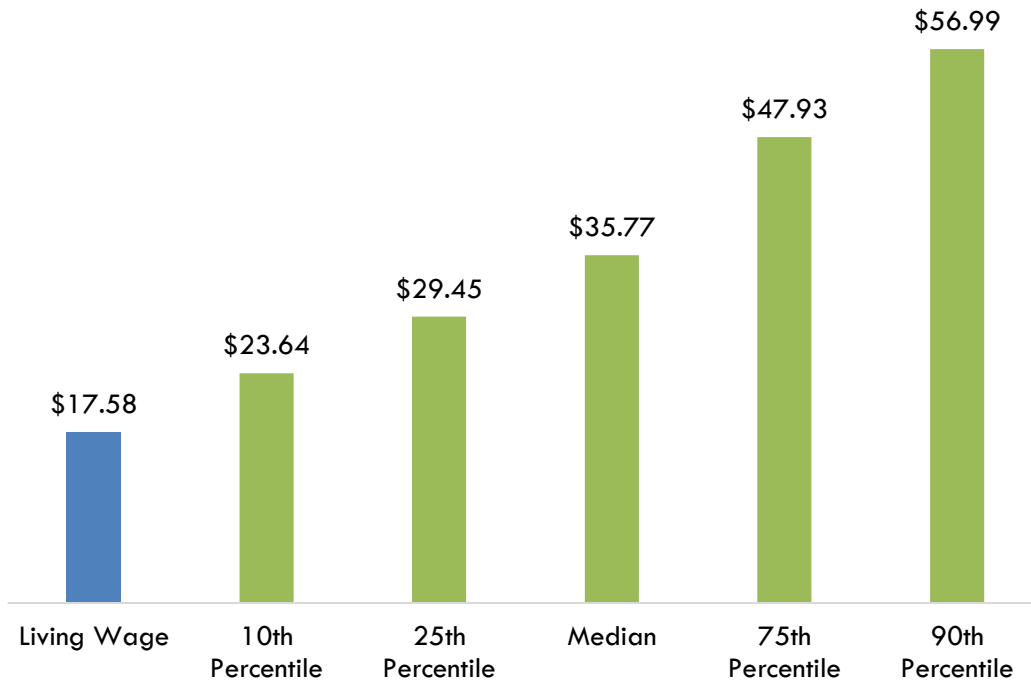
Exhibit 3 contains hourly wages for the occupations of interest. Entry-level hourly earnings are represented by the 25<sup>th</sup> percentile of wages, median hourly earnings are represented by the 50<sup>th</sup> percentile of wages, and experienced hourly earnings are represented by the 75<sup>th</sup> percentile of wages, demonstrating various levels of employment.

Real-time labor market information captures job post advertisements for occupations relevant to the field of study and can signal demand and show what employers are looking for in potential employees, but is not a perfect measure of the quantity of open positions. All representations have been produced from primary research and/or secondary review of publicly and/or privately available data and/or research reports. The most recent data available at the time of the analysis was examined; however, data sets are updated regularly and may not be consistent with previous reports.
