The South Central Coast Center of Excellence for Labor Market Research (SCC COE) prepared this report to determine whether there is a supply gap in the SCC regional labor market related to four middle-skill occupations:

- *Tax Preparers (13-2082)*
- *Bookkeeping, Accounting, and Auditing Clerks (43-3031)*
- *Payroll and Timekeeping Clerks (43-3051)*
- *Brokerage Clerks (43-4011)*

Based on the available data there appears to be a supply gap for these accounting occupations and typical education requirements for these occupations align with a community college education. However, the majority of annual job openings have entry-level wages below the Self-Sufficiency Standard living wage. **Therefore, due to some of the regional labor market criteria being met, the COE endorses this proposed program.**

¹ The living wage endorsement criteria in this report uses the University of Washington's Center for Women's Welfare Self-Sufficiency Standard, which the COE refers to as a living wage; the living wage for Los Angeles, San Luis Obispo, Santa Barbara, and Ventura counties, last updated in March 2024.

Demand:

- The number of jobs related to these accounting occupations is projected to decrease 3% through 2029 in the SCC region. There is projected to be 1,226 annual job openings due to job replacements.
- Hourly entry-level wages for these accounting occupations in Santa Barbara County range from \$14.15 to \$23.30; 100% of annual job openings have entry-level wages below the Self-Sufficiency Standard living wage (\$29.80 for Santa Barbara County).
- There were 2,149 online job postings for these accounting occupations over the past 12 months. The highest number of postings were for bookkeepers, accounts payable specialists, and tax experts.
- The typical entry-level education for these accounting occupations ranges from a high school diploma or equivalent to some college, no degree.
- Between 32% and 49% of workers in the field have completed some college or an associate degree as their highest level of education.

Supply:

- There was an average of 545 awards conferred by seven community colleges in the SCC Region from 2021 to 2024.
- Non-community college institutions conferred an average of 49 related awards from 2020 to 2023.
- SCC community college students that exited Accounting programs in the 2022-23 academic year had a median annual wage of \$44,322 (\$21.31 per hour) after exiting the program and 38% attained the living wage (Self-Sufficiency Standard).
- Throughout the SCC Region, 76% of Accounting students that exited their program in 2021-22 reported that they are working in a job closely related to their field of study.

Demand

Occupational Projections:

Exhibit 2 compares historical and projected changes in employment for these occupations compared to the number of jobs in 2019. Notably, employment for these accounting occupations in all counties faced a significant decline from 2019 to 2024 across the SCC Region and California. From 2024 to 2029, employment for these accounting occupations is projected to steadily decline in all areas.

Exhibit 2: Historical and Projected Employment for Accounting Occupations in the SCC Region, 2019-2029




Exhibit 3 shows the five-year occupational demand projections for these accounting occupations. In the SCC Region, the number of jobs related to these occupations is projected to decline 3% through 2029. There is projected to be 1,226 jobs available annually. Ventura County has the highest number of jobs and annual openings, but employment is projected to decline through 2029.

Wages:


The labor market endorsement in this report considers the entry-level hourly wages for these accounting occupations in relation to the living wage of the county where the requesting community college is located. This report was requested by Santa Barbara City College, which is in Santa Barbara County. Wages for other counties are included below to provide a complete analysis of the SCC Region.

In addition to the Self Sufficiency Standard living wage, data for the MIT Living Wage, updated on February 10, 2025, is provided as a reference. Currently, the MIT Living Wage in Santa Barbara County is \$30.98. Both figures account for geographic-specific costs of necessities such as housing, food, health care, and transportation to assess the cost of living, and are notated in the exhibits below.

Santa Barbara

All (100%) annual openings for these accounting occupations have entry-level wages below the Self-Sufficiency Standard living wage for one adult (\$29.80 in Santa Barbara County). Typical entry-level hourly wages range between \$14.15 and \$23.30. Experienced level wages are above the living wage for all four occupations. Exhibit 4 shows the wage range for each of these accounting occupations in Santa Barbara County and how they compare to the regional living wage, sorted from lowest to highest entry-level wage.


Exhibit 4: Wages by Occupation in Santa Barbara County



Northern Los Angeles

The majority (98%) of annual openings for these accounting occupations have entry-level wages below the Self-Sufficiency Standard living wage for one adult (\$24.03 in Los Angeles County). Typical entry-level hourly wages range between \$17.88 and \$30.52. Median hourly earnings for these accounting occupations in Northern Los Angeles County are above the living wage. Exhibit 5 shows the wage range for each of these accounting occupations in Northern Los Angeles and how they compare to the regional living wage, sorted from lowest to highest entry-level wage.


Exhibit 5: Wages by Occupation in Northern Los Angeles County



San Luis Obispo

The majority (95%) of annual openings for these accounting occupations have entry-level wages below the Self-Sufficiency Standard living wage for one adult (\$22.15 in San Luis Obispo County). Typical entry-level hourly wages range between \$16.53 and \$25.77. Median hourly earnings for these accounting occupations in San Luis Obispo County are above the living wage. Exhibit 6 shows the wage range for each of these accounting occupations in San Luis Obispo County and how they compare to the regional living wage, sorted from lowest to highest entry-level wage.


Exhibit 6: Wages by Occupation in San Luis Obispo County



Ventura

The majority (94%) of annual openings for these accounting occupations have entry-level wages below the Self-Sufficiency Standard living wage for one adult (\$24.53 in Ventura County). Typical entry-level hourly wages range between \$17.64 and \$30.99. Median hourly earnings for *Payroll and Timekeeping Clerks (43-3051)*, *Bookkeeping, Accounting, and Auditing Clerks (43-3031)*, and *Brokerage Clerks (43-4011)* are above the living wage, while experienced level wages for *Tax Preparers (13-2082)* are below it. Exhibit 7 shows the wage range for each of these accounting occupations in Ventura County and how they compare to the regional living wage, sorted from lowest to highest entry-level wage.

Job Postings:

There were 2,149 online job postings related to these accounting occupations listed in the past 12 months in the SCC Region. Exhibit 8 shows the number of job postings by occupation. Approximately 45% of job postings were in Ventura County.

Of the 2,149 postings, the majority (61%) were for *Bookkeeping, Accounting, and Auditing Clerks* (43-3031), followed by *Tax Preparers* (13-2082), as shown in Exhibit 9.


Educational Attainment:

The Bureau of Labor Statistics (BLS) lists the following as the typical entry-level education for these accounting occupations:

- High School Diploma or Equivalent
 - *Tax Preparers (13-2028)*
 - *Payroll and Timekeeping Clerks (43-3051)*
 - *Brokerage Clerks (43-4011)*
- Some College, no degree
 - Bookkeeping, Accounting, and Auditing Clerks (43-3031)

The national-level educational attainment data indicates between 32% and 49% of workers in the field have completed some college or an associate degree as their highest level of education. Exhibit 12 shows the educational attainment for each occupation, sorted by highest community college educational attainment to lowest.

Of the 41% of the cumulative job postings for these accounting occupations that listed a minimum education requirement in the SCC Region, 76% (666) requested a high school diploma or an associate degree, 23% (203) requested a bachelor's degree, and 1% (7) requested a graduate or professional degree.


The college with the most completions in the region is College of the Canyons (297), followed by Ventura College (113), and Santa Barbara City College (45).

Exhibit 14 shows the annual average community college awards by type from 2021-22 to 2023-24. The plurality of the awards are for associate degrees, followed by certificates between 16 and less than 30 semester units, and certificates between 30 and less than 60 semester units.

Community College Student Outcomes:

Exhibit 15 shows the Strong Workforce Program (SWP) metrics for Accounting programs at Santa Barbara City College (SBCC), the SCC Region, and California. Of the 6,763 Accounting students throughout the region in the 2023-24 academic year, 1% (60) attended SBCC.

SBCC students that exited accounting programs in the 2022-23 academic year had lower median annual earnings (\$34,796 or \$16.73 per hour) compared to all Accounting students in the SCC Region (\$44,322 or \$21.31 per hour) and statewide (\$47,912 or \$23.03 per hour). A lower percentage of SCC Region Accounting students attained the living wage (38%) compared to all Accounting students in the state (48%).

To comprehensively analyze the regional supply, it is crucial to include data from other institutions offering accounting training programs. Over the past three years (2020-2023), there were 49 related awards conferred by two non-community college institutions under the related Classification of Instructional Programs (CIP) codes:

- Accounting (53.0302)
- Accounting Technology/Technician and Bookkeeping (52.0302)

No awards were conferred for the following CIP codes:

- Taxation (52.1601)

Regional Demographics


This section examines demographic data for SCC community college students in Accounting programs compared to the SCC labor force, along with occupational data, to identify potential diversity and equity issues addressable by community college programs.

Ethnicity:

Exhibit 17 compares the ethnicity of SCC community college students enrolled in Accounting programs, the overall SCC labor force, and occupation-specific data for the four accounting occupations included in this report.

Notably, 56% of workers employed in these accounting occupations are white, which is much higher than the labor force (43%) and community college Accounting students (30%). Conversely, 54% of community college Accounting students are Hispanic or Latino, which is higher than the labor force (42%) and these accounting occupations (30%).

Exhibit 17: Program and County Demographics by Ethnicity




Age:

Exhibit 18 compares the age of SCC community college students enrolled in Accounting programs, the overall SCC labor force, and occupation-specific data for the four accounting occupations included in this report.

The majority (53%) of workers in these accounting occupations are Later Career/Retirement (50 and Older) age, which is significantly higher than the labor force (33%) and community college Accounting students (3%). Conversely, 70% of community college Accounting students are Pre-Career/College Age (24 or Younger), which is significantly higher than the SCC labor force (15%) and these accounting occupations (5%).

Exhibit 18: Program and County Demographics by Age




Sex:

Exhibit 19 compares the sex of SCC community college students enrolled in Accounting programs, the overall SCC labor force, and occupation-specific data for these accounting occupations.

There is a majority of female workers in these accounting occupations (86%), which contrasts with the labor force (46% female) and community college students (48% female).

Examining disaggregated data for each occupation (not shown), only one occupation has a majority of male workers: *Tax Preparers* (57%), which has the lowest entry-level wages of all four accounting occupations.

Appendix A: Methodology

Traditional Labor Market Data

The SCC COE prepared this report by analyzing data from occupations and education programs. Occupational data is derived from Lightcast, a labor market analytics firm that consolidates data from the California Employment Development Department (EDD), U.S. Bureau of Labor Statistics (BLS) and other government agencies.

Data included in this analysis represents the labor market demand for relevant positions most closely related to the proposed program as expressed by the requesting college in consultation with the SCC COE. Traditional labor market information was used to show current and projected employment based on data trends, as well as annual average awards granted by regional community colleges.

Program supply data is drawn from two systems: Taxonomy of Programs (TOP) and Classification of Instructional Programs (CIP).

Using a TOP-SOC crosswalk, the SCC COE identified middle-skill jobs for which programs within these TOP codes train. Middle-skill jobs include:

- All occupations that require an educational requirement of some college, associate degree or apprenticeship;
- All occupations that require a bachelor's degree, but also have more than one-third of their existing labor force with an educational attainment of some college or associate degree; or
- All occupations that require a high school diploma or equivalent or no formal education, but also require short- to long-term on-the-job training where multiple community colleges have existing programs.

The SCC COE determined labor market supply for an occupation or SOC code by analyzing the number of program completers or awards in a related TOP or CIP code. The COE developed a "supply table" with this information, which is the source of the program supply data for this report. TOP code data comes from the California Community Colleges Chancellor's Office MIS Data Mart (datamart.cccco.edu) and CIP code data comes from the Integrated Postsecondary Education Data System (nces.ed.gov/ipeds/use-the-data), also known as IPEDS.

TOP is a system of numerical codes used at the state level to collect and report information on California community college programs and courses throughout the state that have similar outcomes. CIP codes are a taxonomy of academic disciplines at institutions of higher education in the United States and Canada. Institutions outside of the California Community College system do not use TOP codes in their reporting systems.

Online Job Postings Data

Online job postings data, also known as real-time labor market information, captures job post advertisements for occupations relevant to the field of study which can signal demand and show what employers are looking for in potential employees but is not a perfect measure of the quantity of open positions. Online job postings data is sourced from Lightcast, a labor market analytics firm that scrapes, collects, and organizes data from online job boards such as LinkedIn, Indeed, Glassdoor, Monster, GovernmentJobs.com, and thousands more.

There are several limitations when analyzing job postings. A single job posting may not represent a single job opening, as employers may be creating a pool of candidates for future openings or hiring for multiple positions with a single posting. Additionally, not all jobs are posted online, and jobs may be filled through other methods such as internal promotion, word-of-mouth advertising, physical job boards, or a variety of other channels.

Additionally, Lightcast uses natural language processing (NLP) to determine the related company, industry, occupation, and other information for each job posting. However, NLP has limitations that include understanding contextual words of phrases; determining differences in words that can be used as nouns, verbs, and/or adjectives; and misspellings or grammatical errors.⁵ For these reasons, job postings could be assigned to the wrong employer, industry, or occupation within Lightcast’s database.

Geography

The South Central Coast region encompasses San Luis Obispo, Santa Barbara, and Ventura counties, as well as parts of Northern Los Angeles County. Exhibit 19 shows the 34 ZIP codes used to define Northern Los Angeles County.

Though traditional labor market information is available at the ZIP code level, it does not always add up to data reported at the county level for multiple reasons:

- ZIP codes are not official geographically bounded areas, unlike states and counties.
- ZIP codes may cross county lines, such as ZIP code 93461, which is primarily in San Luis Obispo County, but also crosses into Kern County.

For these reasons, the number of jobs and average annual openings for each county may not add up to the total for the SCC Region. However, considering jobseekers may cross county lines for opportunities, the traditional labor market data is reflective of opportunities available to jobseekers in the SCC Region.

Additionally, job postings data is available only at the city or county level. To analyze job postings for the entire SCC region, the SCC COE developed a list of cities available in Lightcast for analysis. Additionally, demographic data is not available at the ZIP code level but is available at the Census Bureau’s Public Use Microdata Area (PUMA) level. Demographic data was sourced via IPUMS and analyzed by the SCC COE.
